

Our Goal: *A Safe Learning Environment for Every Child, at Every School*

Students often experience harassment, bullying and physical violence at school. Those who are gay, lesbian, bisexual, transgender or questioning their sexuality, or those who are perceived as different by others are especially vulnerable.

In Washington State, 15% of 8th graders and 12% of 10th graders report having been harassed at school for being gay, lesbian or bisexual whether they actually are or not (Healthy Youth Survey, 2008). And the Safe Schools Coalition gets reports every month of bullying and physical assaults due to students' gender expression or bias related to sexual orientation. Teen Health Surveys conducted by school districts have also documented harassment and fear of violence felt by sexual minority and heterosexual students alike.

Often educators may not have the understanding, tools or support to intervene and stop harassment from happening, or to investigate and respond appropriately.

All too often, gay and lesbian youth feel they are being blamed for the problem, and are left vulnerable to continuing danger.

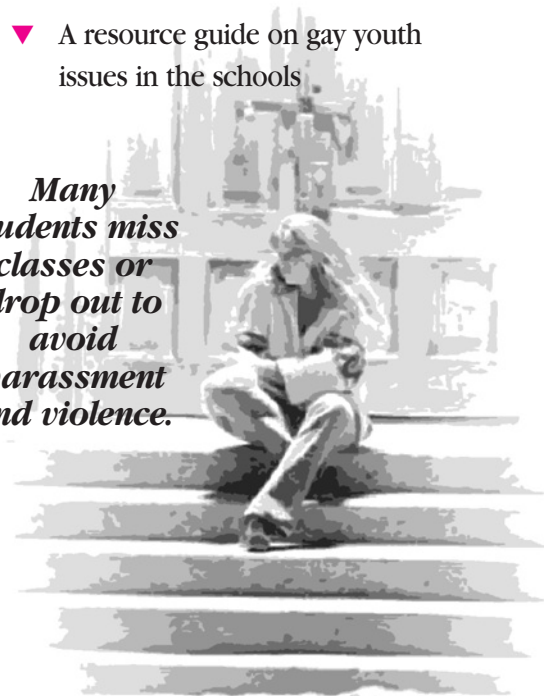

- ▼ Advocates to speak to your school administrators and other employees

What is the Safe Schools Coalition?

It is a partnership of 50+ community organizations, school and government agencies, churches, and youth groups (and hundreds of individuals) working together

We believe that every child and teen deserves to feel welcome at school. We work to end all bullying and violence, especially anti-gay harassment and other bias-based discrimination.

What is a Safe Schools Intervention?

It is a way for an individual student or a school administrator to get help with anti-gay bullying or harassment anywhere in Washington State. You do *NOT* have to be gay, lesbian, bisexual or transgender to use our services.

“Coming home from school, the guys who harassed me at school drove by, shouting names and swerving the car at me. I had to jump to avoid being hit.”



First, you email the Intervention Team or call the Intervention Hotline (Actually, it's the King County Sexual Assault Resource Center hotline; they help us with these calls - including the ones that aren't sexual assaults.) If you need it, the telephone staff can help you to develop a temporary safety plan. Then, you let us know how to contact you. A volunteer Intervention Specialist will get back to you within twenty-four hours. With your Intervention Specialist you can plan what to do next. If you need it we can

- ▼ meet with your principal
(with you or not)
- ▼ meet with your family
- ▼ offer to provide training for your staff
- ▼ provide copies of other districts' inclusive policies and procedures
- ▼ suggest some great curricula, videos, posters and books
- ▼ recommend local support people and agencies in your town or county

Legal Rights and Responsibilities

Public schools should be accessible to all students. Each student has a right to learn in a safe and supportive environment.

Courts have upheld that right
