(1) HRC's MEMBERSHIP – Background: Safe Schools Coalition (SSC) suspended the Human Rights Campaign's membership last March because HRC's refusal to oppose a version of the Employment Non-Discrimination Act (ENDA) that excluded protection for trans folks was a violation of the SSC mission. We decided in September to consider reinstating HRC due to a lot of work they have done re: trans issues this year, but only if they had decided to oppose a non-inclusive ENDA if such a bill should be introduced again.

So Frank contacted HRC national (Allison Herwitz, HRC's Federal Legislative Director) and asked whether HRC had made that decision. Allison said she's not the right person to answer that question, but would help facilitate the conversation. She said Frank needs to speak with the board president.

There was discussion about whether or not HRC would publicize their stance on this for the upcoming year. Marsha suggested that SSC needs to speak with Joe Solmonese to get them to solidify their stance. Frank, Heather, Gabi, and Penny all said they would help on talking with Joe (HRC's Executive Director) or the Board President. Frank will take the lead.

It was also suggested that we (as individual community members) email HRC and let them know about our concern over the issue and where HRC stands on it if we so desire.

(5) WASHINGTON STATE LAW & POLICY WORK GROUP

The Bullying Report was recently published (from Sr. Research Associate Kyra Kester of the Social and Economic Sciences Research Center at Washington State University) and there will be a hearing about it in Olympia Dec. 4th @ 130-House Hearing Room B Obrien building. For a copy of the report, contact Dr. Kester (360-576-6030 ext. 21, kkester@wsu.edu) We agreed that the new Media Swat Team could write op-ed pieces for the Seattle, Tri-cities and Spokane papers to coincide with the hearing (Stefanie and Marsha/Josh will talk). The Work Group is also preparing for the 2009 legislative session-they have discussed what they can do – especially efforts that will not require funding. They are considering drafting legislation or seeking administrative fixes for these issues:

- A) Beef up Bullying Act to improve dissemination to students, standards for investigation and record-keeping, OSPI posters on rights/contacts
- B) Possible change to the administrative code that prohibits schools from asking “sexual behaviors” questions in public health surveys of students.
